## DESCRIPTION

---

The academic cooperation between Canadian and European higher education institutions has a **long-established tradition**. The first formal EU-Canada agreement was signed in 1995, and aimed initially to promote greater understanding between Europeans and Canadians and to foster high-quality human resources. Under the successive agreements, joint projects on curriculum development, vocational and language training, and student exchange schemes were developed. By October 2011, a total of 107 transatlantic consortia were funded, involving 765 European and Canadian partners. More than 5,600 students have participated in transatlantic exchanges<sup>1</sup>.



**The Rectors Seminar 2012 "Europe-Canada: The Future of Academic Cooperation"** will give an impetus for strengthening the existing links between Canadian and European higher education institutions. It will aim to address the global challenges faced by universities on both sides of the Atlantic, and encourage university leaders to jointly develop new paradigms for collaboration.

The Seminar is organised by **UNICA (Network of Universities from the Capital Cities of Europe)**, associating 43 universities from 32 capitals with a combined strength of over 120,000 staff and 1,500,000 researchers and faculty members; **European Network for Canadian Studies (ENCS)**, gathering all the associations of Canadian Studies in Europe at the national and multinational levels; **and the two leading universities in Brussels: Université libre de Bruxelles and Vrije Universiteit Brussel.**

The conference will bring together Rectors/Presidents from European and Canadian universities, high-level policy makers from the European institutions, representatives of the Canadian government, and the media.

Through presentations on Canadian and European higher education landscapes delivered by experienced keynote speakers, the Seminar will seek to provide useful examples of best practices, and allow the participants to bring new approaches and ideas for collaboration back home. The results of the Seminar will be disseminated as policy recommendations to European and Canadian decision-makers.

**The Seminar will be held under the patronage of Mrs Androulla Vassiliou, Member of the European Commission and European Commissioner for Education, Culture, Multilingualism, Sport, Media and Youth.**
