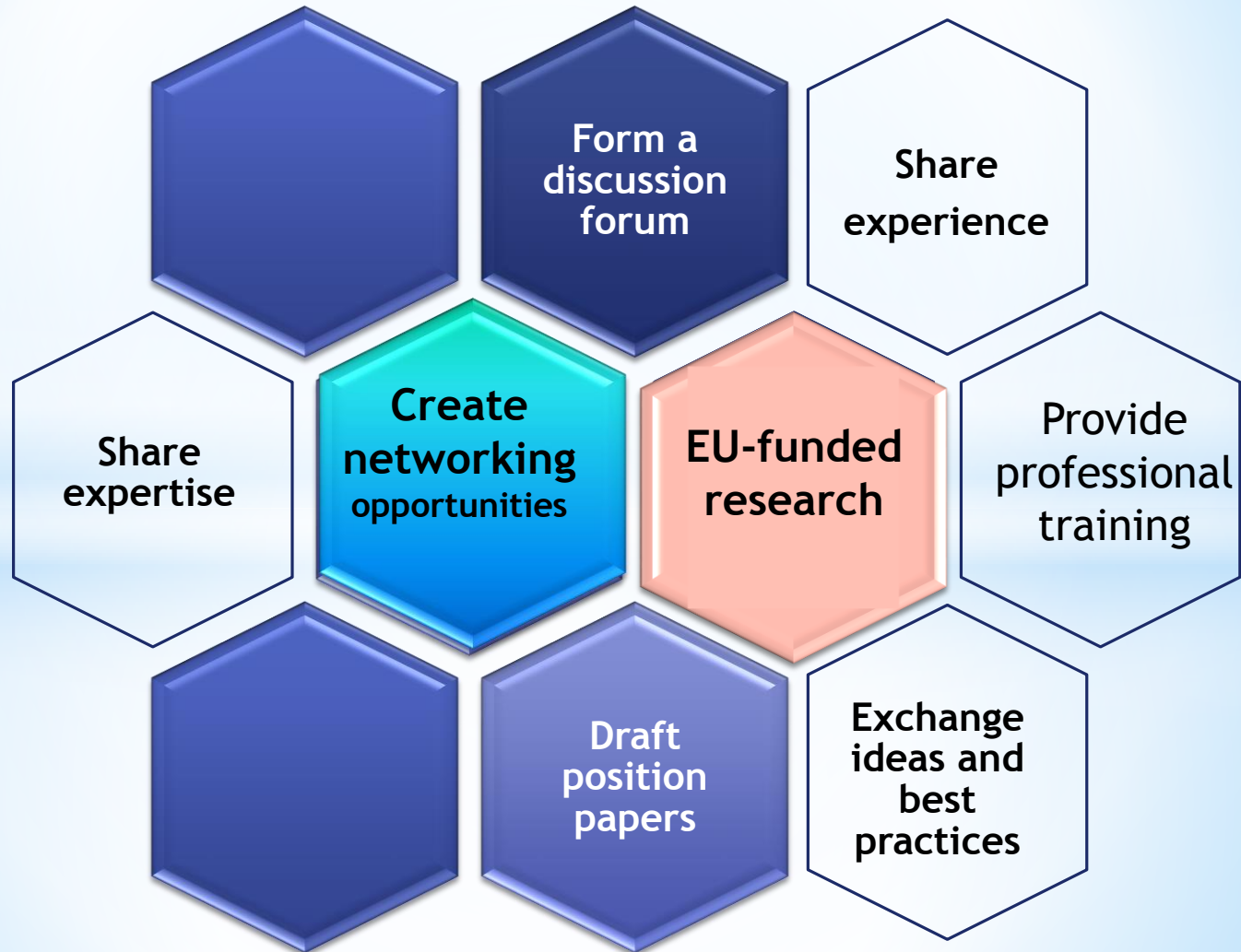
EU Research Liaison Officers Working Group
